Violence Abuse Types

Physical Abuse

Hitting, slapping, shoving, grabbing, pinching, biting, hair pulling, etc. are types of physical abuse. This type of abuse also includes denying a partner medical care or forcing alcohol and/or drug use upon him or her [1].

Emotional Abuse

Undermining an individual's sense of self-worth and/or self-esteem is abusive. This may include, but is not limited to constant criticism, diminishing one's abilities, name-calling, or damaging one's relationship with his or her children [1].

### Economic Abuse

Controlling or restraining a person's ability to acquire, use, or maintain economic resources to which they are entitled. This includes using coercion, fraud, or manipulation to restrict a person's access to money, assets, credit, or financial information; unfairly using a person's personal economic resources, including money, assets, and credit, or exerting undue influence over a person's financial and economic behavior or decisions, including forcing default on joint or other financial obligations, exploiting powers of attorney, guardianship, or conservatorship, or failing or neglecting to act in the best interests of a person to whom one has a fiduciary duty [1].

### Sexual Abuse

Coercing or attempting to coerce any sexual contact or behavior without consent. Sexual abuse includes, but is certainly not limited to, marital rape, attacks on sexual parts of the body, forcing sex after physical violence has occurred, or treating one in a sexually demeaning manner [1].

### Statistics:

The U.S. government reports that intimate partner violence, which includes physical, emotional, and sexual abuse, continues to affect a significant portion of the population. In 2021, approximately 4,970 women were victims of homicide, with 34% of those murders committed by an intimate partner. This highlights the severe consequences of domestic violence, particularly for [2].

### Psychological Abuse

Elements of psychological abuse include – but are not limited to – causing fear by intimidation; threatening physical harm to self, partner, children, or partner's family or friends; destruction of pets and property; and forcing isolation from family, friends, or school and/or work [1].

### Technological Abuse

An act or pattern of behavior that is intended to harm, threaten, control, stalk, harass, impersonate, exploit, extort, or monitor another person that occurs using any form of technology, including but not limited to: internet enabled devices, online spaces and platforms, computers, mobile devices, cameras and imaging programs, apps, location tracking devices, or communication technologies, or any other emerging technologies [2].

### Where to find help?

In an emergency, call your local emergency number or law enforcement agency. The following resources also can help:

Someone you trust. Turn to a friend, loved one, neighbor, co-worker, or religious or spiritual adviser for support.

National Domestic Violence Hotline. Call the hotline for crisis intervention and referrals to resources, such as women's shelters.

Your health care provider. A health care provider typically will treat injuries and can refer you to safe housing and other local resources.

A local women's shelter or crisis center. Shelters and crisis centers typically provide 24-hour emergency shelter as well as advice on legal matters and advocacy and support services.

A counseling or mental health center. Counseling and support groups for women in abusive relationships are available in most communities.

A local court. A court can help you obtain a restraining order that legally mandates the abuser to stay away from you or face arrest. Local advocates might be available to help guide you through the process.

It can be hard to recognize or admit that you're in an abusive relationship – but help is available. Remember, no one deserves to be abused [3].

This topic is highly relevant because domestic violence impacts millions of individuals, often causing long-term psychological, physical, and social harm. Addressing it is crucial not only to protect victims but also to break cycles of abuse that can span generations. Combating domestic violence strengthens families, promotes mental health, and builds safer, healthier communities.
